CONTEXT

On 19-20 June, the network of national platforms is organising its 7th plenary meeting in Paris. The first day, the 19th of June, will be an open session for partners to identify ways to improve the detection, investigation and sanctioning of the manipulation of sports competitions.

The morning will be dedicated to reflecting on the progress made over 10 years of combatting manipulation. The afternoon will focus on exploring possible futures, inspired by innovative approaches from other sectors.

The second day, the 20th of June, will be dedicated to a closed session exclusively for national platforms participating in the Group of Copenhagen.

2015-2025: Where do we stand today?

Over the past ten years, significant progress has been made in the fight against manipulation. There is better detection, more prevention, more investigations, and more national platforms, but not necessarily more sanctions. What explains this gap? What are the current challenges?

The global landscape of sports betting has changed significantly. What are the impacts, and how does this affect the fight against manipulation?

When it comes to detection, what are we identifying today, and how have detection systems evolved alongside the growth of the sports betting market? Are we able to uncover cases of match fixing, or more subtle forms of manipulation—such as spot fixing, including markets like yellow cards? Do we have any visibility into what’s happening in illegal markets?

And what about intelligence and investigations, whether disciplinary or criminal? Where do we currently stand, and what can be done to increase the number of sanctions?

2025–2035: Looking ahead – what comes next?

Looking ahead, how can we anticipate the evolution of transnational criminal organisations involved in sports manipulation? As their methods grow increasingly sophisticated, reinforcing our capacity to respond becomes essential.

Could artificial intelligence play a greater role, not only in intelligence gathering and investigations, but also in detection and even performance analysis? Might we draw inspiration from the tools and strategies used to uncover market manipulation in the financial sector or combat cyberfraud?

Exploring these parallels could open new avenues for more proactive and effective approaches in the fight against manipulation in sport.

Now and in the future, cooperation remains key to tackling these transnational threats. How can we strengthen this cooperation in the coming years, both at national and international levels?

OBJECTIVE

The aim of the open session is to support national platform representatives in defining a roadmap and taking concrete operational steps to improve detection and increase the number of investigations.

What are the expected results?

- ❖ A clearer understanding of recent developments—what has worked well, and what has worked less well in recent years.
- ❖ Practical guidance to better address today’s challenges while anticipating future trends.

PARTICIPANTS

A one-day, in-person meeting, gathering approximately **50 to 75 participants**, including representatives of the national platforms participating in the Group of Copenhagen.

All key stakeholders involved in this issue will be invited to participate in the discussions: representatives from the sports sector, relevant regulatory bodies, judicial and law enforcement authorities, lottery organisations, private betting operators, data companies and investigative journalists.
